The Civil Defense Process - State

State of Oregon

- -Plaintiff has 180 days to file tort notice
- -Tort cap limits in Oregon
- -Types of lawsuits (claims) that will be heard in state court
- -Pros and cons for having a case filed in state court



The Civil Defense Process – Federal

- Federal Court
- –Plaintiff has two-years to file complaint–No tort cap limits
- -Types of claims heard in federal court
- □ 42 U.S.C. § 1983 (civil rights)
- Plaintiff entitled to attorney fees if prevail
- –Pros and cons for having a case heard in Federal Court



Civil Defense Process - Event To Trial

- Event
- Notice of tort claim
- Pleading by plaintiff (complaint)
- Response to complaint
 Answer
- -Motion to Dismiss



Civil Defense Process – Event To Trial, Cont.

- Discovery
- -Interrogatories, Requests for Production
- Depositions
- Motion hearings
- Pre-trial conference
- Trial
- Possible appeal

- Absolute Immunity
- Qualified Immunity
