Action Items for Entity Admins – Aug. 31 Deadline

REVIEW ALL USER LISTS

- 1. Archive any users who are no longer employees
- 2. Make sure all emails are current
- 3. Update job titles, departments and supervisors as necessary.

To assist you with this effort, Brenda Chapin can provide you with a user report in Excel format. Contact <u>Brenda</u> to receive the report or for assistance with bulk edits. All requests for bulk edits must be received by Aug. 31. After this date, no requests for bulk user imports/corrections will be accepted.

Note: Any user that hasn't logged into the system, been assigned a training or attended a CIS Instructor-led training since Jan. 1, 2017 will be archived Sept. 1, 2018 and will not be migrated to the new system as an active user.

REVIEW YOUR LEARNING PLANS, COURSES, AND RESOURCES

- Archive any that are outdated or will not be assigned in the future
- Follow up on incompletes if the assignment is no longer valid, unassign

Note: Any resource, course or learning plan that hasn't been used (assigned, completed with course, etc.) since Jan. 1, 2017 will be archived Sept. 1, 2018 and will not be migrated to the new system.

New Courses Added to Catalog

We have added five online courses developed by Oregon OSHA to the CIS Learning Center catalog, along with brochures, fact sheets (if available) and sign-off quizzes. These courses are only available to members with CIS Workers' Comp coverage.

Note: For all of the above courses, learners will need to complete the "Course Completion Sign-Off" test found on the course activities page in the learning center to connect the course completion to their transcript. If they need to complete the FEMA quiz for certification, they will need to do that on the FEMA website, and also complete the test in the CLC.

Internet Explorer (IE) 9 and 10 Support Ends

Microsoft no longer supports IE 9 and 10. Beginning July 28, 2018, our current LMS vendor, SumTotal, will no longer support these browser versions. Defects or performance issues that appear only in IE10 or previous versions will not be investigated or addressed.

If you typically use Internet Explorer, SumTotal recommends switching to IE 11 or Edge. Chrome and Firefox browsers are also supported. Please notify your supervisors and employees prior to July 28 of this change. If users continue to use either of these browsers some functionality may no longer work.
